- c) Libellous or slanderous matter, as defined by law;

As the producer/presenter, I assume full responsibility for the content of all program material, created or included, produced and will ensure that such program material will not violate the rights of any third party.

I have obtained all approvals, clearances, licenses, etc. for the use of any program material that I am submitting for broadcast. This includes but is not limited to approvals by broadcast stations, networks, sponsors, music licensing organizations, copyright owners, performers, representatives, all persons appearing in or referred to in the program material, and any other approvals that may be necessary to transmit the program material over the this channel.
